

**OTIS MANNING MENTORSHIP PROGRAM**  
**MENTORSHIP AGREEMENT**

The following represents the Contract between REVEREND DR. OTIS MANNING ("**Mentor**") and \_\_\_\_\_ of \_\_\_\_\_ ("**Mentee**"). This agreement will begin upon acceptance and execution by Mentee and shall remain valid for the duration of the Mentorship Program.

**RECITALS**

1. Dr. Otis Manning is the founder of God Family Ministries International; a Bible believing, non-denominational charismatic Church co-founded with his Wife Prophetess Joy Manning. The Church is based in Kingston Jamaica, with local and international branches;
2. Dr. Manning's vision is to preach the Gospel to all the world; making disciples and showing forth the glory of the Lord through his love and his power. The evangelical mission is to change and liberate lives through every possible medium; whilst raising up new missions to carry out the core function.
3. This Mentorship Program is designed to train and promote Leaders in every area of life for work in the Kingdom of God.
4. The Mentee has met the eligibility requirements for the program, and is committed to investing the time required to participate in and complete the program.

NOW THEREFORE IT IS MUTUALLY AGREED AS FOLLOWS:

1. **The Agreement:** Mentorship is a partnership effort focused on developing the Mentee's spiritual awareness, critical thinking within a context of "Kingdom Principles", and abilities; in order to help the Mentee identify and achieve his/her God-ordained purpose and work-related goals. The Parties agree to work together for the achievement of this objective under the guidance and leadership of the Mentor.
2. **Mentor's Obligations:** The Mentor's primary obligation is to devise and implement a program that is in keeping with the principles of discipleship and kingdom leadership. The Mentor will:
  - (a) allocate sufficient time and maintain a schedule of activities appropriate to meet the objectives of the program.
  - (b) maintain the Mentee's confidence and provide the necessary tools and activities to guide the Mentee's development.
3. **Mentee's Obligations:**

- (a) Mentee must be committed and able to respond to the Mentor's unpredictable schedule.
- (b) Mentee must give priority to the demands of the program.
- (c) Mentee's failure to comply or cooperate with the reasonable instructions or requirements of the program will result in termination of this Agreement.
- (d) Mentee must study and become familiar with the protocols and activities of discipleship as demonstrated by Jesus and his disciples.
- (e) Mentee must commit the stipulated number of hours monthly to the program.
- (f) This is a God-centered, faith-based program and all Mentees are expected to adhere to the scriptural principles of honor and righteous living in the conduct of their personal affairs.
- (g) Each Mentee is required to satisfy and maintain the eligibility requirements established by the Program Administrator.

**4. Eligibility Requirements:**

- (a) Mentee must attain a minimum of 14 years of age; parental consent is required for persons below the age of 18 years.
- (b) Mentee must be affiliated with or recommended by an established local or international Ministry.
- (c) Mentee must sign and return the Mentorship Contract along with the required letter of recommendation.

**5. Term & Termination:** Either Party may terminate this Agreement immediately upon notice. The Mentor may terminate this Agreement without notice if the Mentee fails to maintain the eligibility requirements of the program or commits a material breach of the terms of this agreement.

**6. Good Faith:** The Parties agree to act in good faith towards each other and all participants of the program, and to maintain the honor and dignity of the Kingdom at all times.
